ERG Africa, active in the mining sector, organises a workshop to support entrepreneurship as a lever for growth in the Lualaba Province

On Thursday, August 29, 2024, in Kolwezi, Eurasian Resources Group in Africa, a major player in the mining sector in the Democratic Republic of Congo (DRC) through its exploitation of the copper and cobalt sectors via its four main subsidiaries – Metalkol SA, COMIDE SARL, Boss Mining SAS, and Frontier SA – organised a multi-sectoral workshop to promote local entrepreneurship.
